

SILVER RIDGE PARK WESTERLY HOMEOWNER'S ASSOCIATION 2025 POOL RULES

HOMEOWNERS AND GUESTS

Pool hours are from 10:00AM- 8:00PM. The pool is open for any homeowner who wishes to do morning swimming laps only at 9:00 AM, however, a second person must be present at the pool. There is **NO** swimming unattended.

All homeowners in good standing as defined by the Bylaws and NJ Administrative Code must be current with dues and assessments.

All homeowners must show their blue homeowner's badge upon entering the pool area to the monitor on duty. Every resident listed in a Living Unit at the Association Membership Certification received a homeowner's badge. If a badge is misplaced or lost, homeowners are required to request and purchase a new one for use during this pool season. The cost is \$18.00 per badge, per homeowner.

Guests must acquire a guest pool pass from the pool monitor upon entering the pool area and Guests will be required to sign in.

Every home may bring 1 guest free of charge to the pool, however, up to 5 additional guests may accompany a homeowner at a charge of \$5.00 per guest per day or \$15.00 per guest for a season pass. *One free guest pass per household per day*.

Additional passes are only to be sold to Silver Ridge Park Westerly homeowners in good standing and their HOPA Occupants, not residents of neighboring communities.



Guests under 16 years of age are permitted to use the pool from 10:00 am till 1:00 pm. All under the age of 16 must leave the pool area by 1:15 pm. All under the age of 16 **must** be accompanied by an adult responsible for their safety and conduct. There will be **no** charge for children 16 years of age or under to attend the pool.

Children under 3 years of age are **not** permitted in the pool area. Children 3 years+ must be toilet trained to use the pool.

Adult and/or child swim diapers are **not** permitted in the pool at any time.

Individuals with signs or symptoms of infectious or contagious disease, cold, nasal discharge, cuts, bandages, skin eruptions, or other infections are prohibited from using the pool.

It is suggested that hair longer than shoulder length be tied as a ponytail. Water shoes are permitted; however, they are not to be worn to the pool but changed upon entering the water. <u>Streetwear</u> is **not** permitted in the pool. Shirts designated for swimming are permitted.

POOLSIDE COURTESY

There is absolutely No saving of tables, chairs, or lounge chairs.

Food **is** permitted by the poolside. It is required that all residents clean up after themselves.

Please retract table umbrellas when leaving the poolside area

POOLSIDE SAFETY

No alcohol or glass containers of any kind are permitted poolside.

Diving and jumping of any kind are Not permitted.



Running or rough and rowdy playing is Not permitted in the pool area.

Rafts, footballs, and toy surfboards are **Prohibited**. Arm floats, noodles, noodle chairs and belts are allowed. Beach balls can be used for tossing around and/or volleyball by adults if the pool is not crowded and residents in the pool are asked first.

CLUBHOUSE RULES

No animals are permitted on the pool property.

Wet bathing suits are **NOT** permitted in the clubhouse/ kitchen. Please wear footwear when entering restrooms, clubhouse, and kitchen areas.

Smoking and vaping are permitted only outside of the pool area in designated smoking areas.

The pool committee members, designated pool monitors, and the Board of Trustees are the final authority on questions and interpretation of the listed rules. This includes questions concerning decorum conduct and admissions.

The Board of Trustees reserves the right to close the pool area for Club events.

Failure to abide by the above rules may result in the forfeiture of your pool access for a period of time determined by the Board of Trustees.
